Just a few past initiative presentations and where they are now...



Family and Caregiver Training Academy: This program, now known as the Family and Caregiver Training and Support (FACTS) Program is being piloted at the UWMC NW's Center for Behavioral Health and Learning. <u>https://facts.psychiatry.uw.edu/</u> providing a hub for evidence informed, reliable information, resources, and skills training for anyone supporting an adult loved one who is living with a serious mental health condition.

First Responder Therapeutic Response Team: The King County Sheriff's Office therapeutic response unit is in final stages of hiring 6 new health professionals to the initial team, and continues to work and develop training across the entire field of co-response for effective partnerships and cross agency coordination.

The Bachelor-Level <u>Behavioral Health Support Specialist role</u> to expand the workforce: Definition of requirements for certification is almost complete from the Department of Health. Educational partners are starting to offer this curriculum around Washington State.

Housing Stability for Youth in Courts: Now in its fourth year of sustained funding from the state, the program has expanded from the initial four pilot sites to six counties in Washington state, and influenced the 2023 Federal Prevention Services for Youth Act.

Advancing Mental Health Education in Schools: Now a national movement after having created the first ever teacher-facing online curriculum resource in <u>www.mentalhealthinstruction.org</u>. Beginning with Mental Health Literacy programs, this resource is now poised to expand to Social Emotional Learning, Substance Misuse and Suicide Prevention curricula.
